

Our Challenge



Our Solution

 Project Groundwork is MSD's program to significantly reduce sewer overflows

 Includes hundreds of sewer and stormwater management projects across Hamilton County

Phase 1

- 2009 2018
- \$1.14 billion (2006 dollars)



Progress to Date

 Phase 1 is on budget and MSD is working hard to meet Consent Decree schedules for substantial completion – implementing schedule recovery procedures

 89%, or 102 of 114 projects, completed for Phase 1 (2009-2018); Lower Mill Cre€¹ Project is 1 of 114 projects

 The Lower Mill Creek (20 different contracts/subprojects) in 4 different watersheds, estimated cost of \$244 million (2006\$)



Lick Run Project: Integrated stormwater management project

- Reduces sewer overflows into the Mill Creek at lower cost than a deep tunnel
- Constructs new storm sewers and green features to collect and carry stormwater to the Mill Creek
- 12 separate projects, including Lick Run Greenway



Projected Lick Run Project Benefits

 Based on a "typical year of rain," nearly 400 million gallons of combined flows are eliminated at CSO 5 into the Mill Creek

 Ensures that 88% of flow is treated or returned to Mill Creek as stormwater




- Improves water quality in the Mill Creek






Wyoming & Minion Avenues Under Construction: Spring 2017 – Spring 2018



Main Features



 Plus 16,000 linear feet of storm sewers constructed in and around the Greenway

Additional Features

- Multi-use paths
- Extensive landscaping, including baby "moon" trees
- Stormwater planters on south side of Queen City Avenue
- Lighting, railing, retaining walls
- Force main to recirculate water from the pond to Headwaters
- Educational and cultural signage

Property Demolitions

- Demolition of 9 more buildings by this fall
- About six buildings are staying in place, including Cincinnati Fire Station #21 and the strip mall at Queen City & Grand
- MSD is currently in negotiations with Family Dollar to purchase and relocate the store



Utility Relocations

- GCWW (water mains)
- Duke Electric (poles)
- Duke Gas (gas mains)
- Cincinnati Bell (cable)
- Time Warner/Spectrum (cable)
- Temporary traffic impacts along Queen City and Westwood avenues

Construction Considerations

- Morning, night and weekend work will be required
- Typical work hours: 7 a.m. to 5 p.m. weekdays
- Multiple areas under construction at any given time
- Site safety is our #1 priority!



Neighborhood Impacts

- Construction disturbances minimized as much as possible
 - o Monitoring for noise
 - Dust/dirt suppression (watering)
 - Traffic plans approved by CDOTE
- Existing playground open through summer 2017 (new playground after construction)
- Water spray park open through summer 2017 (will reopen after construction)
- Basketball courts removed (new courts after construction)




Traffic Impacts

- Periodic lane restrictions on Queen City and Westwood avenues
 - Will keep all lanes open during am/pm rush hour
- Road closures on cross streets sequentially to minimize traffic impacts: Van Hart, Harrison, Beekman, Kebler, State (southbound lane) and Grand
- City DOTE will review and approve all traffic plans
